Introduction

Biodiversity is the variety of all life on Earth. It includes all species of animals and plants – everything that is alive on our planet. Biodiversity is important for its own sake, and human survival depends upon it¹.

Under the Natural Environment and Rural Communities Act 2006 there is a duty on public authorities in England, including Parish Councils, to have regard to conserving biodiversity as part of their policy or decision making. This was further strengthened by the Environment Act 2021.

Parish councils should be able to show that they are meeting their duty to have regard for conserving biodiversity if they have identified ways to integrate biodiversity when they:

- develop policies and strategies and put them into practice;
- respond to planning applications;
- manage their land, buildings, and resources;
- make decisions about procurement;
- implement economic, environmental, and social programmes.

The Local Area

Aust parish is a rural area, with a variety of habitat types including the internationally important Severn Estuary SAC/SPA² and several sites of local or national importance. The biodiversity importance of the area is described in detail in the Aust Parish Biodiversity Action Plan³ produced by South Glos. Council.

Parish Council assets and resources

Aust Parish Council does not own any land except for the Woodwell Meadows nature reserve in Littleton. Woodwell Meadows is managed by South Glos. Council under a management agreement. The parish council co-ordinates occasional volunteer work parties which carry out practical improvement tasks within the Woodwell Meadows reserve.

The council does not own or operate any buildings, plant, or powered equipment other than the clerk's laptop.

Planning – strategic plans	<p>Strategic level plans drawn up by SGC or WECA will be be informed by advice from specialist ecology and landscape officers, but local knowledge is also important:</p> <ul style="list-style-type: none"> Consider possible biodiversity impacts or potential benefits on areas or locations which may supplement advice from county/regional staff 	Ongoing
Purchasing of assets and consumables	<ul style="list-style-type: none"> Take account of biodiversity or environmental impacts in procurement decisions, for example by choosing recycled or energy efficient products where possible; Prioritise sustainable transport where feasible, for all travel on council business.
