2025-03-1 To receive apologies

Apologies were received from Cllrs Ian Jenkins and Anne Wiseman.

2025-03-2 To receive declarations of Interest and requests for dispensations

There were no declarations of interest or dispensation requests.

2025-03-3 Public Forum

2025-03-4 To approve the minutes of the last meeting held on 11th February 2025

It was RESOLVED that the minutes of the previous meeting held on 11th February 2025 be approved as a correct record subject to the following modifications:

2025-03-5 Parish matters for decision

2025-03-5.1 To receive an update on EDF's plans for saltmarsh creation

Cllr. Warren reported that EDF have announced a change of preferred strategy. They are moving back to installation of an Acoustic Fish Deterrent, as they believe technology has now improved such that this can be done without excessive risk. If the new version of the AFD is approved, this will mean there is no need for additional mitigation through creation of saltmarsh. All planning and design work on the various saltmarsh proposals has therefore been stopped.

EDF reserve the right to resurrect the saltmarsh plans in the future if required, but at the present time they do not expect to do so.

Wildlife survey work may still be carried out around Littleton, but only with permission of the landowner. No other survey work will be happening and the compulsory land entry orders have been removed.

It was RESOLVED that no further action is required of the council at this time.

2025-03-5.2 To consider an application to register ownership of Littleton Pond

It was RESOLVED that the clerk should apply for a caution against first registration to be put on the pond and surrounding area of common land.
